Parking permits for residents can be obtained on application to the council by submitting the form below. Allow 7 working days for your application to be processed. Payment is required by BACS transfer to the following account:

Please enter the reference Parking Bay Number and your surname e.g "05SMITH" when you make your BACS transfer to allow us to match payment with your online application form.

With effect from the $\mathbf{1}^{st}$ April 2024 following fees apply:

£120 per space per year or £13.5 per month

Once we receive confirmation that payment has been made your permit will be issued. Please note our data protection and conditions of use below in the information section below the form.

Please contact the Clerk if you are unable to make payment by BACS and require an alternative arrangement.

Please note the vehicle registration number is required to process the application. Permits are not transferable unless indicated*

*At the full council meeting on 22nd of March 2023 minute reference 23/052, it was agreed that up to 2 vehicles registered at the same address may be added to each pass. Conditions of use

- Annual Parking Permits are valid for use in the designated part of Probus Village Hall car park
 only. The permits are specific to the specific vehicles, the registration number of which is
 displayed on the permit, and are valid from 1st April to the 31st of March the following year.
 It is the responsibility of the holder to apply for a replacement at the end of the valid period.
 Reminders will not be sent to permit holders.
- Parking is only allowed during the period shown on the permit.
- Permits are not transferable to other vehicles. A replacement permit for a vehicle with a
 different registration number can be applied for without charge on return of the existing
 permit
- The permit must be prominently displayed showing the registration number immediately behind the front windscreen of the vehicle to which they apply.
- Permits may not be copied, altered or misused.
- Failure to display a valid permit or meet the terms and conditions of issue and/or use may result in enforcement actions.
- The permit allows parking only at the designated bays of the Village Hall Car Park. Permits will not be issued for any vehicle that does not fit in the marked bays.
- Vehicles to be parked will be defined as cars or light vans. No heavy commercial vehicles over 2.5 tonnes will be permitted. Permits will only be issued for camper vans in exceptional circumstances. A special application must be made to the Clerk of the Parish Council.
- Probus Parish Council accepts no liability in respect of loss or damage to any vehicle or the contents of any vehicle.
- All vehicles must be legal and roadworthy, otherwise permits & tickets will be invalidated, and enforcement actions might be taken.
- Any permit issued will remain the property of the Council and may be cancelled or invalidated at any time (with a refund provided).
- The Parish Council retains the right to withdraw a parking permit from, or refuse to issue a parking permit to, anyone who fails to adhere to these conditions.
